Yu-Chuan (Jack) Li: Editor in Chief of BMJ Health and Care Informatics: Professor Li has been a pioneer of Medical Informatics research and a board-certified dermatologist in Taiwan. He is the founder of the Graduate Institute of Medical Informatics in Taipei Medical University. He has been the Principle Investigators of many national projects in Electronic Health Record, Patient Safety Informatics and Medical elearning. He is also author of 140 scientific papers and 3 college-level textbooks. Currently, he is the Dean of College of Medical Science and Technology in Taipei Medical University, and a Distinguished Professor of the Graduate Institute of Biomedical Informatics.

Siaw-Teng Liaw: Deputy Editor of BMJ Health and Care Informatics: Professor Liaw is a clinician researcher with expertise and experience in clinical and health informatics and systems research. He trains medical students and General Practice Registrars at the UNSW Sydney and SW Sydney Local Health District General Practice Unit. He co-founded the WHO Collaborating Centre (eHealth) and Yunus Social Business Health Hub at UNSW. He is a Foundation Fellow and Past President (2005-7) of the Australasian College of Health Informatics, Fellow of the American College of Medical Informatics. He was recently elected to the inaugural class of 100 of the International Academy of Health Sciences Informatics.
